



Conditions for Participation

Samsung Galaxy Note10 | Note10+ Pre-order Trade-in Promotion

The organizer of the **Samsung Galaxy Note10 | Note10+ Pre-order Trade-in Promotion** is Samsung Electronics Switzerland GmbH, Giesshübelstrasse 30, 8045 Zurich, Switzerland (hereinafter referred to as "Samsung").

1. As part of the **Samsung Galaxy Note10 | Note10+ Pre-order Trade-in Promotion**, participants can pre-order a new Samsung Note 10 or Note 10+ by August 22 2019 – prior to the official sales launch date in Switzerland – and trade in their old smartphone for a trade-in credit.
2. The **promotion period is from August 7 2019 to August 22 2019**. The purchase date on the purchase receipt or confirmation of the pre-order applies. Pre-orders may only be placed with participating dealers.
3. This promotion only applies to purchases of a Samsung Galaxy Note10 or Note10+ supplied by Samsung Electronics Switzerland GmbH to participating dealers located in Switzerland or Liechtenstein.
4. After pre-ordering a Samsung Galaxy Note 10 | Note 10+, participants can trade in their old smartphone for a trade-in credit. Smartphones from other manufacturers can also be traded in. The trade-in credit paid for each old smartphone depends on the model and the condition the phone is in. The trade-in credit is estimated on the basis of the information about the condition of the smartphone provided when registering. After successful registration, the smartphone must be sent, together with the pre-order confirmation, by post to mobiletouch; the address label will be sent to the participant by e-mail. The trade-in credit will be paid out within 30 days after the final check of the condition of the smartphone. If the actual trade-in credit differs from the estimated figure, the participant will be contacted by mobiletouch. In such a case, the participants can, on request, have their old smartphone returned instead of receiving the actual trade-in credit. 5. Pre-orders submitted outside the dates stated under points 2 and 4 are not eligible for this offer.
6. End customers (customers who buy products for their own use) resident in Switzerland or Liechtenstein are eligible to participate.
7. Samsung reserves the right to reject as invalid any entries that are incomplete or do not comply with these Conditions for Participation.
8. Furthermore, Samsung reserves the right to suspend, cancel or prematurely terminate the promotion at any time in the event of technical failure or for other important reasons.
9. Samsung reserves the right to declare participation as invalid if inaccurate, misleading or fraudulent documents are submitted, and where necessary to initiate legal proceedings against participants who violate these rules.
